You will find that the TREASURY CORP OF VICTORIA is also registered on the US stock exchange (CIK#: 0000898608 <http://www.sec.gov/cgi-bin/browse-edgar?action=getcompany&CIK=0000898608&owner=include&count=40>) identifying the state of Victoria simply a business entity that has obligations to report to its overseas owners.

Civic Compliance Australia that forwards debt collection accounts to the Sheriff's office is also actually not a business or government department, but simply a registered trademark with no ABN, according to a letter from the Department of Justice - State of Victoria dated August 2011.
