Please find the attached Courtesy Notice as an effort to bring peace, harmony, and clarity to what may be perceived as confusion and controversy.

As I mentioned on the phone yesterday Luke, there are recent developments unfolding that you may not be aware of, that are changing things significantly and for the better. With regard to the enclosed Courtesy Notice, I do call your attention to the following: Respondent [you] are specifically advised that you are now acting personally in your job, you do not have the safety net of the former STATE OF VICTORIA - DEPARTMENT OF JUSTICE corporation (<http://abn.commerce.com.au/32790228959>) to assist you, therefore you are personally liable for every action you take under Common Law and preserved by public policy UCC 1-103, and Universal law. Please see Schedule A of the Courtesy Notice for my terms of contract with you. How do you avoid being invoiced for agreeing to the terms of the Courtesy Notice? You do not contact me via telephone or in writing ever again. For example in my Schedule A, 'if' you call me again, you will be invoiced personally.

Why am I sending you this Courtesy Notice? Am I trying to make money from you? No. STATE OF VICTORIA - DEPARTMENT OF JUSTICE and I have no contract, and therefore no agreement, due to the UCC filings by OPPT. Specifically see True Bill: WA DC UCC Doc # 2012114776, Oct. 24, 2012] in fact the former STATE OF VICTORIA - DEPARTMENT OF JUSTICE very likely has no legitimate contracts with any of its customers; therefore you are opening yourself up to unlimited personal liability with every former STATE OF VICTORIA - DEPARTMENT OF JUSTICE customer you contact for a toll payment, late notice, 'infringement notice' or 'enforcement order'.

Please do inform others about this specific situation as well as the greater awakening that is unfolding. What we do today will advance society and unleash a golden era going forward.
